These are all the records found responsive to your request.


Please be advised that this property is located within unincorporated Bensenville. Please contact DuPage County to conduct a search of their records for the information you are seeking.

You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.
