The Village has identified 90 requests/inspections regarding rodents in 2024.

The Village has 29 active bait stations, 19 of those have started in 2024.

You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.

This memo is intended to update the Village President on the ongoing efforts to control the rodent issues within the Village of Bensenville.

President DeSimone,

I wanted to provide you with an update on all the ways Community & Economic Development has been working on the rodent issue. Please note, this is not necessarily ready for public consumption at this point. We have been doing lots of work behind the scenes and are gearing up for a more public offering soon. This includes working with Anthony Sumner and the media team to get the message out about how we are handling this ongoing problem. I think it's worth noting that this is not just a Bensenville problem. Just this month, Wood Dale started a rodent mitigation program that we are looking hard at to see if it makes sense here in Bensenville.

Tracking Reported Sightings

All rodent related issues should come through CED. Any call anyone at the Village takes should be sent to us. The reason for this is that we are keeping track of each reported incident in Cartegraph. Along with SeeClickFix rodent complaints, we worked with our GIS consultant to start mapping each incident. With the aid of a visual map, we are able to look for hot spots. We started this in January of this year. I've included a map for your review.

We have been keeping detailed spreadsheets of reported sightings, which I've also included with this memo. These provide information on the complaint, what type of property we are dealing with, contact information, and what steps have been taken to mitigate the rodent issue. The entries date back to June of 2023.

Rodent Abatement

For rodent complaints received, CED inspectors will perform a site visit. On a site visit, inspectors will determine if there is corrective action that should be taken by the property owner. Rodents need food and places to build their burrows. We frequently find unkept yards, people feeding animals, piles of wood, and other such violations. Inspectors will issue correction notices usually requiring 7 days to comply.

CED took two major steps starting in 2023. The first was to start paying for bait stations at residential hot spots identified through our tracking. We work with two pest control companies: Riteway Pest Control and C & C Pest Control. We do this primarily when we determine that there are rodent burrows at a location. Bait stations are maintained for a minimum of 6 months. CED is currently paying for this out of our budget. We also keep a detailed spreadsheet of where these are located, and it is again included with this memo.

CED also passed a revised Insect and Pest Control ordinance late last year (Ord. 53-2023). This ordinance mandates that all residential rental properties, including large multi-family buildings, must treat for pests (rodents) on a monthly basis. It also provides stronger language to require tenants of those properties to keep the properties clean if rodents are found.

Rodent Mitigation at Construction Sites

CED staff implemented a new policy related to all permitting that includes any digging on site. As a condition of the permit, the permit holder must have rodent mitigation in place. This requires proof of service, and it must be completed before any digging can begin.

Commercial Garbage Corral Task Force

Just this week, we have all inspectors going to every commercial property with a focus on those with food-related business. Inspectors are looking for clean garbage corrals, making sure the areas are being used correctly, and if a business doesn't have a corral at all, they are issuing correction notices that they must install one. We will have a detailed report on how many correction notices were issued by next week.

Draft Municipal Integrated Pest Management (IPM) Plan

Village Manager Summers drafted the plan which pulls together several of the above items into a cohesive plan and strategy to deal with the rodent issue. CED Deputy Director Ron Herff is discussing the draft with our pest control companies to see if they have any suggestions or feedback for plan improvements before we finalize and begin implementation.


A crucial part of the plan moving forward is education and outreach. Once finalized, we plan to work with Anthony Sumner on an educational push to the community, including a spotlight, social media, and a dedicated landing page on the Village website.

Future Pest Mitigation Program Offerings

CED staff has been researching what other communities have been doing to solve the ongoing rodent issue. Again, this is not strictly a Village of Bensenville problem. Wood Dale recently established a cost share program for residents. The City has contracted with Chem-Wise Ecological Pest Management to offer pest control services to residents and businesses in specified areas where rat populations exist. The services include an initial inspection, installation of an exterior bait station, and three months of follow-up services. The cost for these services is \$70 to the resident for the three-month period. If additional bait stations are requested, there will be an additional charge of \$25 per station. If activity persists beyond three months, residents can enter into a monthly agreement for approximately \$45 per month.

CED Deputy Director Ron Herff has spoken with Wood Dale and their contractor Chem-Wise. The plan is to establish a similar cost share program for Bensenville Residents. Currently, we get better pricing from our two pest abatement companies. They both seem eager to expand into a new program. Staff anticipates having a draft program available in the next week.

Rodent Mitigation at the Construction Site

Effective immediately

In an effort to control the rodents around the construction site.

1. All permits where digging will be done shall have rodent mitigation. (Fence permits are exempt)
2. Must hire an exterminator to ensure it is completed professionally.
3. Must have proof of service. (Written service contract till the completion of the project.)
4. Bait station to be placed in the inside of the Silt fence.
5. Must be completed before digging can begin.
6. It shall be written in the conditions of the permit.

Municipal Integrated Pest Management (IPM) Plan

Village of Bensenville

1. Introduction

The Village of Bensenville is committed to ensuring a safe and healthy environment for all residents. Effective management of rodent infestations is critical to this mission. Bensenville's Integrated Pest Management (IPM) approach emphasizes prevention, monitoring, and control to manage rodent populations in an environmentally responsible manner. This plan outlines our comprehensive strategy for addressing rodent infestations within the Village.

2. Objectives

- Reduce rodent populations in Bensenville.
- Minimize health risks associated with rodent infestations.
- Implement sustainable and environmentally conscious pest control practices.
- Engage the community in proactive rodent prevention efforts.

3. Integrated Pest Management (IPM) Strategies

A. Prevention

1. Sanitation and Waste Management

- Ensure proper waste disposal and regular garbage collection.
- Promote secure storage of food waste in rodent-proof containers.
- Conduct public awareness campaigns on proper waste management practices.

2. Elimination of Food and Water Sources

- Mandate that restaurants and food manufacturers use rodent proof waste receptacles and have sufficient refuse pickups.
- Encourage residents to store pet food indoors and clean up food spills immediately.
- Remove pet waste from lawns immediately.
- Fix leaky pipes and eliminate standing water in and around homes and businesses.
- Remove fallen fruits, nuts, and other food sources from yards.
- Eliminate fruit-bearing trees from public property and recommend removal from private property in infested areas.
- In impacted neighborhoods, the use of bird feeders should be reduced.

3. Habitat Modification

- Enforce property maintenance code to eliminate clutter and potential rodent nesting sites.
- Promote the trimming of overgrown vegetation and removal of debris.
- Reduce standing water in areas where rodent activity is noticeable.
- Seal cracks and holes in buildings to prevent rodent entry.
- Building permits that require digging shall be conditioned upon including rodent mitigation measures.

B. Monitoring

1. Regular Inspections

- During rental inspections, the properties bait stations will be checked to ensure that rodenticide bait is being used properly.
- Conduct routine inspections of public spaces, parks, and common areas.
- Use traps and tracking powder to monitor rodent activity.

2. Community Reporting System

- Establish a reporting system through See-Click-Fix for residents to notify the Village of rodent sightings.
- Community Development staff will follow up with every See-Click-Fix request. Follow-up may include a site visit to discuss rodent habit and food sources, baiting, or property owner responsibilities.

C. Control

1. Rodenticide Bait Stations

- Continue using third-party vendors for deploying and resupplying rodenticide bait stations to rodent infested areas.
- Ensure bait stations are strategically placed throughout the Village and regularly monitored.

2. Extermination Services

- Require all rental units to maintain a contract with a certified exterminator.
- Require all commercial properties to install and properly refresh rodent bait stations.
- Offer free guidance and support to homeowners seeking professional extermination services.

3. Biological Control

- Explore the use of natural predators, such as barn owls and feral cats, to control rodent populations.
- Promote the installation of owl nesting boxes in suitable locations.

4. Best Management Practices

- The Village will employ a certified Structural Pest Control Technician licensed by the Illinois Department of Public Health (IDPH).
- Rodent abatement will be conducted using the standards established by the National Pest Management Association.
- All activities in the Bensenville Integrated Pest Management Plan will be conducted to maximize effectiveness with consideration of the budget allocation and minimizing harm to people, pets, and the environment.

4. Community Engagement

- **Education and Outreach**
 - Community Development inspectors will provide outreach and free assessments to any resident, property owner, or business inquiring about rodent infestations.
 - Distribute educational materials, such as brochures and flyers, to residents.
 - Utilize social media and the Village website to share tips and updates on pest management efforts.
- **Partnerships**
 - Collaborate with local businesses, schools, and community organizations to promote rodent prevention measures.
 - Partner with neighboring municipalities to share resources and best practices to mitigate regional rodent issues.
 - Engage with refuse haulers to ensure that garbage cans and dumpsters are in good repair to reduce access to rodent food sources.

5. Evaluation and Adaptation

- **Performance Metrics**
 - Track the number of reported rodent sightings and infestations.
 - Monitor the effectiveness of bait stations and other control measures.
- **Review and Adjust**
 - Regularly review the IPM plan and adjust based on feedback and performance data.

Your Message	Good morning, For the first time after living here for over 50 years, I have seen a rat on my property. Mohawk Manor being torn down and the construction site underneath 83 bridge at Irving Park Road could be potential reasons why. I called the village, Brandon came out. He said somebody else had to come out and they were on vacation. A week went by and Brandon called me again saying he would come out that day. Nobody showed up. I got another call saying they would be by today. I don't think I

have to explain why I am concerned, rats carry a lot of diseases in their saliva, urine and fecal matter. I would like you to please follow up with Ron and Brandon and make sure that there is a sense of urgency about this problem that my neighbors and I are having. Brandon also spoke to my neighbor, Ted at [REDACTED], and they found rat holes on his property. Ted told Brandon he is OK with people entering his property and setting traps. I said I am OK with traps being set on my property outside of the backyard fenced area. Since no one has come out in these past two weeks, we have found more holes in the front yard. So clearly, they are expanding. Why has no one taken action?

My other question is if these two major construction sites were happening, you are displacing animals why wasn't there preemptive measures at the sites to prevent these disease carrying animals from spreading into our neighborhood?

My third question is, will you make sure that this gets taken care and then monitored?

Dear Frank and Evan- I am writing to you to beg for your assistance in what is a Public Health topic for the town of Bensenville.

RAT INFESTATION(s).

My family has lived in Bensenville for 50 years and we have NEVER had RATS. This is a safety issue. Below you can bore yourself with the reading our email trail of numerous attempts to get assistance, and lacking support, as well as our hours of phone calls and unreturned messages that are not reflected here.

What is for sure not shown in this email is our fear for our children, pets and ourselves for a public safety issue. Bensenville is a great town and I am proud of my town. 50 years of tax dollars given to this town. And WE are being told because of our address in White Pines we cannot be helped. This is simply unacceptable and we are tired of getting the run around. Before you get the inclination of telling me to reach out to DuPage county- they have not helped and have sent us running in circles. I realize this MIGHT be the first your learning of this topic, however I'd be shocked that you weren't made aware, because there is a Bensenville social media group where over 70 people have reported rats. Those are the people who took time to post, we have jobs and lives that we are trying to manage. And we are tired of this. People have shared that they have reached out to the Village and some guy named Brandon has visited their homes, he's set out a couple traps/poison boxes. This is beyond Brandon. Pest control at this level should not be our responsibility. This isn't a couple of mice. Our count between our two houses is now up to 60 plus in 6 weeks. And this number is only because we have so many traps that we have had to pay hundreds of dollars for.

We cannot get ahead of this. Poison, traps, are not working to get ahead of this. We need help from our town, rats mate and birth at a speed that we have been unsuccessful in getting ahead of. I am no longer confident in our health safety in doing this. Now we have citizens taking these matters into their own hands . Then citizens using pest control entities that if not careful can cause harm- or worse death to children and pets because of toxin levels that can seep into homes. Unfortunately 2 children died in this case. Additionally rats carry DISEASE this is problematic for our TOWN. Rats don't know boundaries of unincorporated as your village representative below has stated. They're by McDonald's, they are in White Pines, they are in Wood Dale - in many areas of Bensenville. This is a Bensenville problem.- not my ISSUE as Kurtis Pazsgay tells me here below. We have been trying to handle this problem. We need your help.

The reason we are contacting you is to confirm that you are made aware of this before future action will be imperative in taking.

Do the major news outlets need to cover this? Do we need to get the blow up strike rats to put out to get more exposure on this so we can get help? Do your citizens need to seek litigation? Does Bensenville want this associated with it's town?

Frank I believe you live in this town- are they on your property? Is your family's health at risk because of these rats? It may not be a problem currently but certainly these rodents have a way of getting in.... I say this because this is everyone's problem and it's in an emergency state and we need our town to protect us. We are looking to you, gentleman, to take this over and solve it.

Please advise immediately of what our options are. Winter is coming and we do not wish for this to elevate further.

Village of Bensenville

1. Introduction

FY 2024 RAT MITIGATION PROGRAM CONTRACT

This CONTRACT, made and entered into **this ____ day of ____ 2024**, by and between the VILLAGE OF BENSENVILLE, an Illinois municipal corporation (hereinafter "VILLAGE"), and RITEWAY PEST CONTROL, INC. an Illinois corporation (hereinafter "Contractor").

RECITALS

WHEREAS, the Village desires to engage the Contractor to provide services (hereinafter "**Work**"), located within the corporate limits of the Village of Bensenville; and

WHEREAS, the Contractor represents itself to be in compliance with Illinois Statutes relating to all matters affecting its status as a corporation operating as a general contractor within the State of Illinois and to have the necessary expertise and experience to furnish such services for the Work upon the terms and conditions set forth herein below:

NOW, THEREFORE, in consideration of the mutual promises herein contained, it is hereby agreed by and between the Village and the Contractor that:

I. SCOPE OF SERVICES

We've only caught that amount because that's what we can catch in the 5 traps that we have. This is getting out of control. If your house/yard isn't being affected NOW -it will be. And winter is coming and they don't like to live outside. Bensenville doesn't want to own it-guess what, It's here. Prior posts about this topic are over 70 posts/people exressing frustration with how to catch RATS! 50 plus years my family has lived here, NEVER 1 rat. Are you going to wait until they are burrowing in YOUR yard? Or maybe when there MULTIPLES walking along your fence line in broad daylight? Or perhaps when they are chewing the body of another rat caught in a snap trap-absolutely disgusting. Or when they are chewing on the mortar of your your bricks in your home, trying to get in. ALL HAPPENING in Bensenville NOT in the city of Chicago. Other towns have programs in place for rat infestation-ours refuses to recognize or support. "Brandon" is not enough. The Village keeps sending people to contact Dupage-Bensenville needs to handle this. Skokie does, google, they have support in place. Voice your opinion NOW because this is a health safety tsunami: just wait until they arrive at your property. You'll be disgusted, afraid and angry. By then it's too late.

District 1 County Board Members:

The Village of Bensenville has been made aware of the following letter that is circulating in unincorporated White Pines. I want you to be informed of it as well as our actions.

Since the pandemic, the Village created an internal program to address pockets of rodent infestations reported to Village Hall. This program involves Village staff investigating complaints and offering strategies to eliminate habitats, food, and water sources that attract rodents. Additionally, we utilize private contractors, paid for by the Village, to bait problem areas.

This summer, likely due to a combination of the cicadas and infrastructure construction, rodent complaints have increased in our community and [surrounding municipalities](#). In response, we are now promoting [our established rodent mitigation program to the public](#), providing solutions to Bensenville residents at no cost.

We have had numerous unincorporated residents contact us requesting the same level of service, which we have had to deny. We simply cannot use taxpayer funds outside of our municipal boundaries.

PLEASE READ ALL OF THIS AND PLEASE email DuPage County contacts listed below.

White Pines Residents there are rats in our neighborhood. The village of Bensenville acknowledges that there is a problem with rats all over Bensenville because of the rat mitigation program that they just launched this past Monday for incorporated residents only. If you access the Facebook *What's Happening in Bensenville* social media site this has been a topic of discussion. MANY posts (over 80) by Bensenville residents writing and people are asking how to kill rats. This mitigation program does not include our neighborhood/unincorporated. An attorney that represents Bensenville says that these rats came from the Illinois Tollway project; created by construction and unearthing these rats. There have been rats all over Bensenville and Wood Dale. This is an infestation and needs to be handled by Bensenville as a whole but they are not providing support for unincorporated. Near Red Oak and Pine Grove ave we have caught in live traps, over 60 rats in about 6 weeks and they keep procreating and we cannot get ahead of this. You might be thinking that you don't have any rats (now) and that may be the case. You don't have rats, yet. Please check your properties for holes near your homes or in your lawns or under your stairs/stoops. They are small holes that are unnoticeable at first. These rats have burrowed within the lawn, they live in log piles, drain pipes, siding in your house- small holes. Rats carry disease this is a health safety topic. It's dangerous for children, all humans and pets. By the time they do arrive at your property they mate at a rate of 1400 baby rats per year. People have been trying to tackle this on their own and have put out poison. Watch out for your children and pets perhaps discovering deceased rats and other animals that have been poisoned. As we have found them (dead raccoon and rats). What is very important that you need to do is **please write to Dupage County District 1 contacts that are listed below here**. The attorney for Bensenville provided these contacts below as a means to push Dupage County into doing something sooner rather than later. **This is urgent. We need you to write to them.** Email is immediate and preferred as it keeps as an electronic record and there's no disputing that they received an email. In the 50 years my family has lived in White Pines, there have NEVER been rats. We need to get rid of them, please write today to the Dupage County individuals below asking for help.

Here is something that you could use to write your email.

Dear Cindy Michael and Sam-This matter is urgent. I am a resident of Bensenville in the White Pines Neighborhood, I am aware of the rat concerns in the Village of Bensenville because they are offering a mitigation program to incorporated Bensenville only. There also needs to be support for White Pines/unincorporated Bensenville. We need you to offer support NOW for the rat infestation that is happening all over Bensenville and especially in the White Pines neighborhood. This is a health safety topic. We are asking that you help us immediately.



Services under this agreement are for single-family homes, individual duplex units, individual townhome units, and multi-unit residential properties. Commercial buildings and offices are excluded, except that municipal properties belonging to Bensenville will be serviced at the discounted rate. The non-discounted, standard rate for each service is listed in red and indicated by a strikethrough.

Inspection, consultation, and setting of one trap: \$130.00 (\$185.00)

The animal trapping process begins with an inspection that includes all ground level areas involved, which may include; the stoop, deck, foundation, window wells, or any other common ground level entry point. After access points are understood and damage is assessed, one or more traps can be set during the same visit. ABC Wildlife will meet with the resident to describe the trapping process and the resident will be instructed on how to contact ABC Wildlife when an animal is in the trap so that ABC Wildlife can pick up the trapped animal as quickly as possible (most of the time the same day, depending on the time of the call, but always before the next calendar day has elapsed).

Return visit: \$81.00 (\$115.00)

Includes the pickup of any trapped animal. There is no additional charge for multiple trapped animals picked up on the same visit, so setting extra traps is often the most economical plan and helps to resolve the problem faster by removing more animals sooner. There is a return visit fee for any return visit, including visits to replace a broken indicator, or reset or re-bait a trap.

Daily trap checking fee (if needed): \$81.00/per day (\$115.00)

While most clients are able to monitor the trap, it is rarely, but occasionally, necessary for ABC Wildlife to check the trap. Such instances include service to homeowners who cannot go outdoors, unoccupied homes being managed by real estate firms, and homes in foreclosure processes.

This fee includes removal of all animals trapped during each 1-day period, and resetting and re-baiting each trap on the property. The return visit fee is not charged to clients if they are assessed a trap checking fee. It's only one or the other.

24-hour (24/7) telephone consultation:

Telephone consultation at any hour of the day or night is free of charge.

Bats flying around the living quarters of a home or behaving abnormally, i.e., fluttering around on the ground.

All other species that cannot be legally trapped with a Class A Nuisance Wildlife Control Permit using a humane box trap.

The services below are not discounted under this agreement.

Animal Proofing:

While animal proofing/exclusion and damage repair can be quoted onsite when required, it is not covered under this agreement.

Dead Deer Removal:

\$650 - \$2,500 depending on time and difficulty

This service includes removal of any material on the ground and disposal of the carcass in accordance with the Illinois Dead Animal Disposal Act. The removal of dead deer from swimming pools, ponds or other bodies of water will incur additional charge and will be quoted in advance on a case per case basis.

Wildlife Emergencies Necessitating Immediate Response Time:

\$350 to \$550 based on whether one or two state-certified biologists are required for the response, and the amount of time spent on the removal, or attempted removal. The fee includes the setting of a trap if the animal could not be hand captured. The fee also includes submitting the animal for rabies testing if human exposure is suspected. Examples of wildlife emergencies include, but are not limited to, an animal that has fallen through a ceiling into the living quarters of a home, an animal that has entered the living quarters of a home through an open door, an animal that is sick or dying that prevents residents from safely entering or exiting their home, an animal that has entered the living quarters of a home and is an immediate threat to property or human health and safety. ABC Wildlife is on-call 24/7 to provide emergency service. Please call 847-870-7175.

Wildlife Trapping Services for Beavers, Muskrats, or Coyotes:

Trapping or removal services for beavers, muskrats or coyotes are not covered in the pricing for any other sections of this Agreement. When beaver, muskrat or coyote dens are found on clients' properties, ABC Wildlife must assess the site and issue a site-specific quotation. Coyote trapping is not allowed in Illinois due merely to the occasional presence of a coyote. Accordingly, ABC Wildlife will not undertake coyote trapping services unless the coyote's den is on the property of the covered party.

Other services performed by ABC Humane Wildlife Control & Prevention that are not included or managed under the terms of this agreement:

- Repairing damage caused by wildlife
- Replacing soiled insulation
- Installing animal-proof products, such as chimney caps, underground screening, structural rodent-proofing
- Replacement of attic fans and vents
- Removal of dead animals
- Removal of animal carcasses from inside of attics, beneath decks and stoops and other confined areas
- Pest control for insects
- Installation of bed-bug proof mattress encasements
- Placing one-way doors call excluders on homes to exclude bat colonies
- Sealing gaps that bats or other wildlife enter through
- Structural inspections of the home to determine how bats gain entry
- Structural inspections of the home to determine how mice gain entry
- Trapping and control of wildlife species not covered by this agreement
- Emergency visits outside of regular business hours
- Animals that must be removed using a tranquilizer gun or noose pole. This is known as a hand capture and is usually an emergency service requiring one to two biologists to remove an animal that is in the living quarters of a home.

Terms and Conditions:

All prices quoted are valid for one year starting on August 7, 2024. Upon mutual consent of both parties.

Language to be added to the Bensenville Website:

As a resident of Bensenville, you may qualify for discounted ground trapping services provided by ABC Humane Wildlife Control & Prevention, Inc. The Village of Bensenville has approved ABC Humane Wildlife Control & Prevention Inc. for wildlife nuisance control on private property.

The Village is not the purchaser of private animal control services and the decision to use ABC Humane Wildlife is that of the property owner and not the Village. The decision whether to use ABC Humane Wildlife, or any other commercial animal control service, is completely up to the resident. ABC Humane Wildlife Control & Prevention, Inc. will charge a private resident directly for the ground trapping and removal of skunks, raccoons, opossums, woodchucks, and squirrels. Residents wishing to use ABC Humane Wildlife Control & Prevention Inc. must deal directly with the company.
