R E S O L U T I O N

WHEREAS: The CITY OF ELMHURST and the VILLAGE OF BENSENVILLE are considering the annexation of certain properties; and

WHEREAS: The respective City and Village desire said annexations to be orderly in nature; and

WHEREAS: The respective City and Village, understanding the problems of County Government of DuPage County; and

WHEREAS: The respective City and Village respect the rights of owners and electors residing in rural territories; and

WHEREAS: The respective City and Village desire an orderly development of lands lying along their mutual borders;

THEREFORE BE IT RESOLVED by and between the CITY OF ELMHURST and the VILLAGE OF BENSENVILLE, that:

The respective City and Village have agreed as a matter of principle that the center line of Grand Avenue from Route 83 to York Street shall constitute their mutual boundary line subject to the owners and electors residing within said territories consenting to or desiring annexation to either City or Village, and further that:

The territory lying East of the center line of York Street, South of Grand Avenue, and North of Lake Street to the County Line shall not be annexed by either Municipality until such time as said territory has resolved it's problems that render it impractical of annexation presently due to certain items of bonded indebtedness, etc. and/or until the Municipalities herein can find an opportunity to further discuss the subject area and find a solution to such problems, and until such time as the area as a whole indicates a desire for annexation; further that:

The Municipalities agree not to rezone any parcel lying within one-quarter (1/4) of a mile North or South of said Grand Avenue until the respective Municipalities have been fully

advised of the proposed rezoning, have diligently strived to agree upon the proposed use and subject to the rights of owners in order to insure an orderly development.

The CITY OF ELMHURST agrees not to annex any territories lying North and West of the intersection of York and Grand Avenues, and the VILLAGE OF BENSENVILLE agrees not to annex any territories lying South and West of the intersection of York and Grand Avenues.
