- 1) Village of Bensenville Business Licenses Issued from 10/1/24 – 11/20/24. (1 pg.)


Personal Email Addresses have been withheld pursuant to Section 7(1)(b) of FOIA.

You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.
