

Good afternoon,

I wanted to reach out with a couple of data requests for your SS4A application and to get Alex and A'Miracle connected from our team, as they'll also be working on this application. I'll bullet point out the information we need below.

- Can you coordinate getting a list of the locations of at-grade crossings in each community that is a part of the coalition? We just need the street name(s) where the crossing is located. The list can be in an Excel or a Word document. What we want to do is look at crash data, traffic data, etc., for the crossings in Lima and compare that to the proposed deployment from TRAINFO. Basically, we just want to double-check that we aren't missing any gaps in what is requested for SS4A.

- We need to decide who will submit the SS4A application and be in charge of administering the grant. There are several different ways to do this. The easiest way would be for either the MPO or DuPage County to submit the application and administer the grant. Another option is for each of the coalition's members to be included as a co-applicant, but one community will need to be identified as the lead applicant. This doesn't really have any impact on the competitiveness of the application, so the best choice to make would be whichever one everyone can agree on.

- Once we have a list of all the at-crossings, we'll need to get crash reports around those crossings. If I remember correctly, we'll need to request those reports from each local police department. Do you want to connect us with a representative from each police jurisdiction, or would you rather us put together data requests and let each community coordinate that with their respective police department?

I think that's it for now. Please let me know if you have any questions or need some additional clarity on any of the information listed above. I hope you all have a great day.
