- 1) Village of Bensenville Business Licenses Issued since December 4, 2024. (1 pg.)

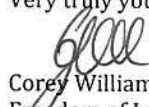
Personal Email addresses have been withheld pursuant to Section 7(1)(b) of FOIA.

You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.
