This is in response to your Freedom of Information Act ("FOIA") request, received via email on March 17, 2025 for the Village of Bensenville – Arthur Court Improvements Bid Results.

At this time, the Village has not made an award or final selection of bids for these projects. Under Section 7(1)(h) of the FOIA, 5 ILCS 120/7(1)(h), the Village may deny a request for proposal or bids for any contract, grant or agreement until a final selection or award is made. As it is the Village's policy not to disclose bids prior to awarding them, I regrettably must deny your request under this section of the FOIA.

The Project is expected to be awarded at the May 21, 2023 Village Board Meeting.
