Pursuant to Section 1-7-3 of the Bensenville Village Code, 65 ILCS 5/5-3-7, and the Employment Agreement by and between the Village of Bensenville, DuPage and Cook Counties, Illinois and Evan K. Summers, as Village Manager, dated June 16, 2021 (the "Agreement"), you are hereby placed on paid administrative leave until such time as the Village Board meets to determine if you will be terminated as Village Manager or return from paid administrative leave to resume your duties.

In accordance with Section 11B of the Agreement, the Village Board of the Village has the right *"to terminate the services of the Manager at any time without hearing, with or without cause, and with notice, subject to the provisions set forth in this Agreement."* Your possible termination as Village Manager will be considered at a special meeting of the Village Board to be called on November 26, 2024. If a majority of the Village Board vote to terminate your services as Village Manager, you will be informed of your official separation from the Village and paid in accordance with the terms of the Agreement.

As you are now on paid administrative leave with the Village, please promptly return all Village records and property in your possession, including your Village issued cellular telephone, computer, keys and identification badge, and any other Village property to the Director of Human Resources & Risk Management. You also need to turn over all usernames, passwords, and personal identification codes for all electronic devices to the Director. Your attention to these matters is appreciated.
