Bensenville, IL – On June 10, 2025, the Village of Bensenville held its official swearing-in ceremony during a special Village Board Meeting. Judge Elizabeth Ciaccia-Lezza administered the oath of office for Trustees McLane Lomax, Ann Franz, Armando Perez, Village Clerk Nancy Quinn, and Village President Frank DeSimone. They were all reelected to serve a four-year term.
