At this time, the Village has not made an award or final selection of bids for these projects. Under Section 7(1)(h) of the FOIA, 5 ILCS 120/7(1)(h), the Village may deny a request for proposal or bids for any contract, grant or agreement until a final selection or award is made. As it is the Village's policy not to disclose bids prior to awarding them, I regrettably must deny your request under this section of the FOIA.

The Project is expected to be awarded at the August 26, 2025 Village Board Meeting.


