Re: September 26, 2025 FOIA Request

Dear Mr. Georgiades & Ms. Slowick:

I am pleased to help you with your September 26, 2025 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on September 26, 2025. You requested copies of the items indicated below:

"I am inquiring for some information through a FOIA request for three properties on York Road, Bensenville.

Number 1- I would like to bring to your attention on the Fourth of July which was a Friday, right after the parade, I started noticing street barricades to be applied between Wood Street and Green Street on the East side of York Rd on Saturday July 5, 2025, it came to my attention what is the emergency going on to cut the street and barricade the street and close down York Road going North. Was IDOT notified for this application?

The cars were diverted going North to May Street to come around Green Street. What I am observing is the street was cut and it was trenched over to the property at 185 York Road.

Corey and Joe what I am inquiring in a FOIA request is what kind of Tap was carried over to this property? who is the owner of the property? this property has the appearance of being abandoned Why is Bensenville responsible to cut the street and bring a service line over for this residence?

with my forty years of construction experience of being a General Contractor, this clearly identifies as a Water Service Tap. Please also forward over the FOIA information as to who the property owner is at 185 York Rd.

Number 2- The property located to the North and next door to 185 York Rd is misleading all emergency departments as the address is labeled as 1905, this address is misleading as it should be 181 York Rd.

I would like to bring to your attention that this property is owned by a Village Trustee.

Cory and Joe we are Bensenville Residents and Taxpayers and we would like this information expedited to us.

Mr. Joe Caracci would know exactly what type of work was performed. What was the emergency to have the street cut on the Saturday after the Fourth of July and having Public works personal working over time.

Corey 185 York Rd has been sitting with the exterior exposed for over two years, the Tyvec wrap has been blowing around for over two years.

Why is the Building Department and Village Trustees allowing for this Building to stay in this condition?

this property clearly shows that it is Abandoned.

Corey I would also like to request a FOIA request for permits for 185 York Rd, 181 York Rd and permits for 14 N York Rd #BW illegal basement apartment."


You are asking direct questions on specific items that are no covered by FOIA.
