

ORDINANCE NUMBER 54-2025

AN ORDINANCE OF THE VILLAGE OF BENSENVILLE, DUPAGE AND COOK COUNTIES, ILLINOIS AMENDING CHAPTER 2 OF TITLE FIVE OF THE BENSENVILLE VILLAGE CODE TO ESTABLISH A FEE FOR USE OF VILLAGE-OWNED ELECTRIC VEHICLE CHARGING STATIONS

WHEREAS, the Village of Bensenville, DuPage and Cook Counties, Illinois (the "*Village*") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, President and Board of Trustees of the Village of Bensenville (the "*Corporate Authorities*") are charged with the responsibility of protecting the health, safety, and welfare of the residents of the Village; and

WHEREAS, the Corporate Authorities have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret, and amend Village ordinances, rules, and regulations; and

WHEREAS, the Village desires to reduce greenhouse gas emissions by increasing access to electric vehicle charging infrastructure including for residents without access to private parking; and

WHEREAS, the Corporate Authorities have determined that it is necessary and in the best interests of the residents of the Village to establish a user fee for electric vehicle charging stations owned and operated by the Village to recoup operational and maintenance costs associated with the charging stations and create a revenue stream to provide for the expansion of this infrastructure; and

WHEREAS, the Corporate Authorities may from time to time amend the text of the Bensenville Village Code when it is determined to be in the best interests of the residents of the Village; and

WHEREAS, the Corporate Authorities find that it is in the best interests of the residents of the Village to provide for the regulations herein specified to promote the health, safety, and welfare of the residents of the Village and the general public.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Bensenville, DuPage and Cook Counties, Illinois, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Corporate Authorities find and determine that it is necessary and desirable to amend the Bensenville Village Code for the purpose set forth herein and that the adoption of this Ordinance is in the best interests of the Village.

Section 3. Chapter 2 ("*Stopping, Standing or Parking*") of Title Five ("*Traffic and Motor Vehicles*") of the Bensenville Village Code is hereby amended by adding the following new Section to read, as follows:

5-2-29: VILLAGE-OWNED ELECTRIC VEHICLE CHARGING STATION USER FEE:

A. The use of a Village-owned electric vehicle charging station and adjacent electric vehicle charging spaces shall be limited to electric vehicles connected to an electric vehicle charging station. A fee of twenty-five cents (\$0.25) per kilowatt-hour (kWh) of energy dispensed shall be paid by a user of any of the Village's publicly accessible electric vehicle charging stations.

B. Vehicles that remain at an electric vehicle charging space after completion of charging shall be charged an additional overstay fee of ten dollars (\$10.00) per sixty-minute interval, which fee shall take effect fifteen (15) minutes after completion of charging.

C. The fees imposed by this section are in addition to, and the user shall be responsible for, payment of any applicable convenience fee, transaction fee, processing fee, or tax that are assessed on the transaction.

D. The Village shall determine the software and hardware by which the fees are collected.

E. Users of Village-owned vehicles are exempt from the fees imposed by this section.

Section 4. This Ordinance, and its parts, are declared to be severable and any section, paragraph, clause, provision, or portion of this Ordinance that is declared invalid shall not affect the validity of any other provision of this Ordinance, which shall remain in full force and effect.

Section 5. The findings and recitals herein are declared to be *prima facie* evidence of the law of the Village and shall be received in evidence as provided by the Illinois Compiled Statutes and the courts of the State of Illinois.


Section 6. All ordinances, resolutions, motions, or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 7. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.


